

# **Articles of Surrender and Reunification of Slaver's Territory as a Free Place of Trade and Market**

**We hold these truths to be self evident, that all people are created equal by the creator; conceived in Liberty and Freedom, that no one will be taken, sold and held as slaves for another ever again.**

**These Articles of Surrender is an agreement to all those signed for the adherence of these terms to insure a free state for all to live in.**

# *To All...*

## *Article 1: Free State, No Slavery*

**No one will be taken, sold, held by forced and/or against their will in service of another in servitude, payment of debt or sexual service.**

**A person can volunteer to perform such service for employment and debt reduction, but no one will be forced to do such things, especially in any action that resembles slavery.**

## *Article 2: Release of All Known Slaves.*

**Anyone being held against their will by any party will be released immediately.**

**Witnessed agreement can be made with the former slave and slave owner for continued service under employment.**

## *Article 3: Reeducation of Released Slaves.*

**Released individuals are to be repatriated to the general population. In repatriation, former slaves will be given free opportunities to education to learn and upgrade skills for better employment as a free person. No one will be turned down due to their former slave/owner status.**

## **Article 4: Public Assistance to Released Slaves.**

**Former Slaves will be given chances to gain employment and be given assistance in home relocation and food through use of public support programs such as 'soup kitchens' and religious community support programs. No one shall be turned away due to former slave/owner status.**

## **Article 5: Open, Free and Fair Market.**

**Released Slaves entering the Trade and Service Market will be granted the same rights and responsibilities as any other market seller/buyer. There will be no collusion, price gouging, or market manipulation to force someone into leaving the market.**

## **Article 6: Punishment for Unfair Treatment of Former Slaves/Owners.**

**Anyone found in the continued action of taking/selling/holding slaves will arrested, tried and serve a sentence of a minimum of 1 year and a maximum of 5 years of hard labor during imprisonment for each and every slave found. Anyone found in action of taking/selling/holding more than 10 slaves can face the death sentence as their punishment.**

**Anyone who forces another into (sexual and non-sexual) service for themselves as a slave will face the same punishment as stated above.**

**Anyone seen in the action of treating former slaves through discriminating action, such as unfair treatment of employment choice, salary**

**compensation, over-pricing of goods and services, denial of service and so on; will have a tariff of 'Unfairness Tax' of 25% of their total income and property. This is to ensure that everyone is treated fairly and equally. Personal disagreements do not apply.**

# **For The former Slaver's Village (aka Slavia)**

## **Article 0: Renaming of the Slavers' Village**

**The Village used by the Slavers will be recreated into a Public Village, complete with its own services like any other. This new Public Village will be known as Slavia. All maps and information will be updated as to its location and its new name. Citizens and residents of Slavia will be known as 'Slavian.'**

## **Article 1: Release Slave and Repatriating into the General Population**

**Released Slaves will be brought back to where they were taken and released to the attention of the general population from which they were removed.**

**Released Slaves will be given back what they one had and lost when forced into slavery. If property cannot be restored, then a monetary value of their loss will be given so they can restart their live anew.**

**Wherever possible, released slaves will be reunited with living family members who were also put into slavery, and the family recreated as a whole as much as possible.**

**Wherever possible, released slaves will be reunited with family members who managed to remain as free members of society.**

## **Article 2: Lost Slaver's Property**

**Property lost due to past conflicts for the release of slaves and battles will not be returned or restored. This is the price of war one has to pay.**

**Lost property can be resold to Slavians if such actions are to be taken by the current owner of such property. Lost property can be rebuilt by Slavians if such supplies are available and sold to them to rebuild with.**

## **Article 3: Opening Free Market in Slavia**

**All the surrounding towns and villages must conduct business with Slavia like any other town. In exchange for this market, Slavia will open its roads and transportation options: Land, Water and Air; along with product manufacturing, storage space and fuel distribution.**

**Fifteen (15) miles of road leading to Slavia must be opened and maintained by the people of Slavia, and connections to various lanes of transportation (highways, waterways, airways) must be kept open and maintained as well. Like the other towns, distribution of news, weather and travel conditions will be freely given to all those that request it in print or radio.**

**Radio Communications with Slavia will be established and maintained as before.**

**Once these are done, the Convoy will add Slavia to its route and Slavian Merchants added to the Convoy when needed or requested.**

## **Article 4: Adding Slavia Merchants to the Convoy**

**To sell their goods to other towns, the Convoy will allow Slavian Merchants to join the line when going through town.**

**Slavia will be a regular trading stop for the Convoy Merchants and Slavian Merchants be part of the Convoy Merchants. Convoy Merchants will be given space and time from which they can go into Slavia to conduct their travelling business.**

**Slavia will provide the space from which this business will be conducted from and the Convoy will create a regularly scheduled time slot for which they will conduct their business in Slavia. This area of Convoy Merchant Business will be accessed by the members of the Convoy and potential customers for free or at minimal cost as per the rules regulations of neighboring towns by agreement with the Convoy. No extra fees or taxes shall apply or be added.**

**The area of business used by the Convoy Merchants will be maintained, cleaned and repaired by said Convoy Merchants when the convoy is in town for its scheduled business ventures. This area in Slavia will be maintained, cleaned and cared for by the Slavia when not in use by the Convoy Merchants and can be used by Slavia for other use.**

## **Article 5: Shared Technologies**

**Being a known Blimp and Zeppelin Base, Slavia will share airship technology with the local towns and villages. It will be used as a major airway stop and station for the local towns and villages who cannot support airships within their territories. This also applies to Railways if any connect to Slavia.**

**Local Towns and Villages will support Slavia's Air (and Rail) Service to reach further towns that the Convoy cannot reach in a timely basis. This includes repairs and maintenance of Slavia's Air Ships, Air Port and Railways and Rail Station (if any).**

**Past services which were closed down due to Pre-Slavia's Slave trading, for example possible Railroad Line and station Closures, will be reopened and access given, these services will be maintained by Slavia and support given by neighboring towns and villages.**

## **Article 6: Future War with Slavia**

**Any town or village signing this treaty will be in alliance with Slavia and will aid in its defense when called upon. Any future war with Slavia for past aggressions will come to an end upon signing this treaty and a new alliance created among former enemies.**

**Likewise, any war Slavia has with any of its neighboring towns and villages for past aggressions also must come to an end upon signing this Writ of Peace.**

**This is an agreement for all those who sign it to share.**

## **Article 7: Decommissioning of Weapons and Slave Vehicles used by Slavia in the Slave Trade**

**Weapons will not be decommissioned or surrendered in order for Slavia to protect and defend itself against future attack from any source. Its**



people are not to give up arms which they need for defense or procurement of food from wild game.

Vehicles used in the former Slavia Slave Trade will be converted for other usage, such as the transportation of food, materials and services.

Vehicles used in Slavia's military will be converted for other usage, such as transport of food, materials and services. There will be a minimal set of vehicles to remain and be used in Slavia's Defense Military and Law Enforcement. This number of vehicles will be determined by the population size and determined need of Slavia.

## **Article 8: Medical and Emergencies**

The neighboring towns and villages around Slavia will provide, share and update what Medical and Emergency Services Slavia may have. This is to ensure Slavia will be capable to assist in any emergency what neighboring towns and village may have. Slavia will also provide emergency and rescue services on the roadways it maintains to the connecting highways, and victims of accident, crime, or circumstance brought into Slavia from the outside on the highways.

## **Article 9: Law Enforcement and Civil Defense**

Slavia will maintain a police and military support for its citizens and residents. Part of the duties of their Law Enforcement and Civil Defense is to provide emergency services and care in case of natural or man-made disasters.

**Slavia's Law Enforcement and Civil Defense will also provide such services to neighboring towns and villages in time of need created from natural or man-made disasters.**

**These services will include: Fire Fighting, Search and Rescue, Law Enforcement, Emergency Medical Treatment, Judicial Procedures and Prisoner Detainment. Such services will cover areas Prevention, Call to Action, Loss Assessment and Recovery.**

# ***For all the Neighboring Towns and Villages Around Slavia.***

## ***Article 1: Shared Market, Technology and Infrastructure***

***In order for the Convoy and others to be able to go through connected towns and villages, Slavia has to maintain and share through free access the Roadways, Airways, Waterways and Railways it has.***

***Anyone providing their own transport must be able to have free passage to and through Slavia. Obtaining supplies and services in Slavia is not necessarily free and must be purchased at the going market rate.***

***Cargo and passenger fees can be minimally charged only if Slavia is providing the means of transport, such as: bus, train, water ferry or airship.***

***In Emergencies, Slavia must provide what emergency services and medical care it has within the range of its connected highways (15 miles or to the point of connection to the main highway, whichever is greater). If victims of accident, crime or circumstance are brought in from outside this range, Slavia must provide what medical services it can provide. If towns are hit with a natural emergency such as major storms or earthquakes, Slavia, along with other towns and villages, will provide emergency support personnel to give assistance to them, and they will if it were to happen to Slavia.***

## ***Article 2: Emergency Services***

**Slavia's Law Enforcement and Civil Defense will also provide such services to neighboring towns and villages in time of need created from natural or man-made disasters.**

**These services will include: Fire Fighting, Search and Rescue, Law Enforcement, Emergency Medical Treatment, Judicial Procedures and Prisoner Detainment. Such services will cover areas in Prevention, Call to Action, Loss Assessment and Recovery.**

### **Article 3: Past and Future War with Slavia**

**Any town or village signing this treaty will be in alliance with Slavia and will aid in its defense when called upon. Any war with Slavia for past aggressions will come to an end upon signing this treaty and a new alliance created among former enemies.**

**Likewise, any war Slavia has with any of its neighboring towns and villages for past aggressions also must come to an end upon signing this Writ of Peace.**

### **Article 4: Tax and Reparations.**

**No neighboring town or village signing this treaty will place an additional tax any citizen, resident or merchant of Slavia for goods and services other than what is already there for their own citizens, residents and merchants.**

**No neighboring town or village signing this treaty will demand reparations for items lost during the slave trade and past conflicts with Slavia.**

## **Article 5: Slave Trade and Slave Market**

**The Days of the Slave Trade and Slave Market are over. Anyone signing this Writ of Peace must free their slaves and endow them with employment and educational opportunities, as well as reunite them with surviving members of their families. They are to assist former slaves in obtaining residence and a welling meaning and well paying jobs that will support former slaves to become contributing and supporting members of society.**

**Slavia's past actions of creating and maintaining the slave market is only part of the problem. The other part rests on the individuals who bought slaves and use them accordingly as such to provide services they would normally pay someone else to do. The ownership of slaves by those within and outside of Slavia is to come to an end.**
